As stated in the Circular, the Chan Family and its associates (together holding 114,723,652 shares which represent approximately 54.53% interest in the Company) have abstained from voting on the Resolution. Other shareholders together holding 18,398,171 shares (which represent approximately 8.75% interest in the Company) have also abstained from voting on the Resolution.

As at the date of the EGM, the Company's total number of issued shares was 210,368,688 shares. The total number of shares entitling the holders to attend and vote for or against the Resolution was 77,246,865. There was no share of the Company entitling the holder to attend and vote only against any resolution at the EGM.

Computershare Hong Kong Investor Services Limited, the share registrar of the Company, has acted as the scrutineer for the purpose of vote-taking in the EGM.
